PROMOTION	Boost Juice 'What's Your Name Game' Campaign

PROMOTIONAL PERIOD	The Promotion will be conducted from commencement of trade on Monday, 9 October 2017 to close of business on Sunday, 5 November 2017.
ELIGIBLE CLAIMANTS	Claims are only open to Singaporean residents who meet the Eligibility Criteria. Claimants under the age of 18 must have parent or guardian approval to claim an offer in this Promotion.
PRIZE	One (1) free Boost Juice smoothie, crush or juice of any size from the current Boost Juice menu, made in accordance with the standard recipe. Additional charges will apply for extra ingredients, including fruit or Booster, added to the smoothie, crush or juice
HOW TO CLAIM	<p>To claim a Prize, an Eligible claimant must visit selected Boost Juice store within Singapore during the Promotional Period and demonstrate (to Boost Juice's reasonable satisfaction) that they have the same first name as of the names selected by Boost Juice to redeem a Prize that day ("meet the Eligibility Criteria"). Boost Juice may require an Eligible claimant to produce a NRIC, passport, driver's license with photo, staff tag with photo, or other formal photo identification in order to claim a Prize.</p> <p>Employees of the Promoter or Boost Juice franchisees will have final determination as to whether a person has met the required Eligibility Criteria to obtain a Prize.
